T1.1 Bid Notice and Invitation to Bid

1. The Endumeni Municipality invites bids for the Reconstruction of Argyll/Browning Street in Dundee, Endumeni .The scope consists of the reconstruction of 1.72km asphalt road including the upgrading of existing road stormwater infrastructure.
2. No bid that is submitted late will be considered.
3. No bids sent or submitted by facsimile, telex, telegram or electronic mail will be accepted.
4. The municipality is not obliged to accept the lowest or any bids.
5. Only bidders who are registered with the CIDB and who are in possession of a **Tax Compliance Status (TCS) Pin** certificate and a copy of their **Tax clearance Certificate** (online printable) from **SARS** are eligible to submit tenders.
6. Endumeni Municipality subscribes to Municipal Supply Chain Management Regulations and Preferential Procurement Policy Framework Act 2000 (Act No. 5 of 2000), Preferential Procurement Regulations 2011. The bids will be opened in public soon after closure and only the name and the tender amount will be read out. The 80/20 preference point system will be applicable, with 80 points for Price and 20 Points for B-BBEE Status Level of Contribution.
7. As per section 38(d) (i) & (ii) of Endumeni Municipality's Supply Chain Management Policy, bidders or any of its directors who are in arrears with their rates and taxes for more than three months or who have failed to perform satisfactorily on a previous contract in the last five years, will not be considered. Bidders are also required to provide proof of their latest rates payment to their municipality.
8. Bids will be adjudicated in terms of the Council's Supply Chain Management Policy.

The compulsory clarification meeting is to be held at **Endumeni Civic Centre, 64 Victoria Street, Dundee** with representatives of the Employer and will take place on **Wednesday, 12th July 2017** starting at **10h00**. Bidding documents will be available from **Friday, 07th July 2017**. Prospective bidders will meet at the **ENDUMENI MAIN COMMITTEE ROOM**.

It is estimated that tenderers should have a CIDB contractor grading designation of **7CE** or higher.

A non-refundable bid deposit of **R500.00**, per document, payable in cash is required on collection of the bid documents. Bids must be submitted on the official bid document obtainable from the Finance Department, **Mr. V G Sonpal (Sunil)** or **Ms P. Khumalo (Phume)** Room 12, Civic Centre, 64 Victoria Street, Dundee during normal office hours prior to the clarification meeting.
