
Bids from highly experienced, qualified and reputable service providers are hereby invited to bid for the **APPOINTMENT OF A SERVICE PROVIDER FOR THE DEVELOPMENT OF THE STRATEGIC ENVIRONMENTAL ASSESSMENT (SEA) FOR ENDUMENI MUNICIPALITY** as per the terms of reference contained in the Bid Document.

1. Price quoted must be valid for at least 90 days from date of closing.
2. Price quoted must be firm and must be VAT Inclusive.
3. Bids submitted late will not be considered.
4. No bid sent or submitted by facsimile, telex, telegram or electronic mail will be accepted.
5. The municipality is not obliged to accept the lowest or any bid.
6. As per section 38(d) (i) & (ii) of Endumeni Municipality's Supply Chain Management Policy, bidders or any of their directors who are in arrears with their rates and taxes for more than three months or who have failed to perform satisfactorily on a previous contract in the last five years, will not be considered.
7. Bids will be adjudicated in terms of the Council's Supply Chain Management Policy, and in terms of functionality as part of the minimum requirements before being evaluated on price, thereafter the 80/20 Preference Points systems as prescribed in the Preferential Procurement Policy Framework Regulations 2017 will be used.
