I/We accept the responsibility for the payment of all consumer fees and charges in respect of the supply of the municipal service and should it be necessary for the Council to hand over my account to their Attorneys for the recovery of any amount due by me I hereby undertake to pay all Attorney and Client fees as well as collection charges and commission by the said Attorneys.

Both parties herewith consent to the jurisdiction of the Magistrate's Court irrespective thereof that the amount in dispute or the nature of the relief sought may exceed the jurisdiction of the Magistrate's Court. Nothing contained herein shall invalidate the Creditor's right to proceed in any other Court of competent jurisdiction.

I/We accept that monthly consumer accounts serves as a final demand and must be paid in full on or before the 10<sup>th</sup> of the month following the month during which services were rendered. In the case of non-payment of the full outstanding account, the services to the property will be discontinued without further notice. The deposit will be adjusted and cut off fees raised. Interest of 12% per annum will be levied on all overdue service accounts. The services will only be reconnected once the outstanding amount plus extra fees have been paid.

This agreement constitutes the whole agreement between the parties and no agreement, representation or warranties between the parties other than those set out herein are binding on the parties.

No amendment or alteration or variation or addition or cancellation of this agreement shall be of any force or effect unless reduced to writing and signed by all parties.

Each person applying at this establishment consents thereto that his/her current Credit Bureau Record will be checked in order to assist in the bona fide business decision of whether credit/service should be granted to the specific applicant or not. Each potential applicant also consents thereto that his/her conduct of the account e.g. non-payment, may subsequently be reported to a Credit Bureau.
