**D 01/04/11/10 MOTION IN TERMS OF SECTION 40 OF THE LOCAL
GOVERNMENT MUNICIPAL STRUCTURES ACT**
(C7/10)

A Motion of No Confidence in the Speaker was put to the meeting.

The Council then decided that a secret ballot would be conducted.

Ballot papers were handed out to Councillors who voted to either remove the Speaker from Office or to retain him as Speaker.

After the votes were cast the ballot papers were counted of which the results were as follows:

1. Remove the Speaker (vote of no confidence): 8 (eight)
2. Retain the Speaker: 3 (three)

The Acting Municipal Manager then requested the Speaker to vacate the chair and called for written nomination for the Office of the Speaker.

After the Councillors caucused, the attached nomination in which it was proposed that Cllr T B Mkhize be elected as Speaker, was handed to the Acting Municipal Manager.

There being no further nominations, it was

RESOLVED

THAT in terms of Schedule 3 of the Municipal Structure Act 1998, Cllr T B Mkhize be elected as the Council's Speaker.



Cllr T B Mkhize thanked the Council for electing him as Speaker of the Endumeni Council and advised that he would serve the Council with dedication.
