RESOLVED

THAT

1. Mr Roy Ramdaw be appointed to investigate alleged misconduct in respect of the promotion of three staff members in the Corporate Service's Department and to two staff members in the Technical Service's Department;
2. With immediate effect the Acting Municipal Manager, Mr J B Maltman, and the Executive Manager Corporate Services, Mr S Perumall be suspended with full pay whereafter they do not make contact with any official in the employ of the Council and leave the premises immediately;
3. The MEC be advised of the Council's decision;
4. The suspension of the Managers mentioned in item 2 above be for alleged misconduct in respect of the promotion of three members of staff in the Corporate Service's Department and two members of staff in the Technical Service's Department;
5. Mr P G Mabilisa, the Communications Manager, be appointed as Acting Municipal Manager and that the Mayor inform him of same;
6. Letters of suspension be written to the Acting Municipal Manager and the Executive Manager Corporate Services by the Mayor, with the assistance of the Senior Manager: Legal & Estates;
7. A Committee consisting out of the following members of the political parties represented in the Council be appointed to determine the terms of reference for Mr R Ramdaw's investigation:
