The Glencoe solid landfill site is situated in the uMzinyathi District and Endumeni Local Municipality between Ladysmith and Newcastle. The landfill site is located on Erf 4322 and Portion 2 of Erf 915 Glencoe on the southern boundary of the Glencoe Townlands area and shares a common boundary with the Remainder of the Farm Uithoek No. 1335.

#### **Scope of Work:**

The scope of the annual external audit is to measure compliance against the conditions stipulated in the Reviewed Waste Management Licence (DC24/WML/0003/2010/REV/2020/01), as well as the revised Operations and Environmental Management Plan (OEMP), dated October 2019, as per condition 4.5.17 of the licence, in addition to other applicable environmental legislation for the Glencoe Landfill Site located on Erf 4322 and Portion 2 of Erf 915 Glencoe, uMzinyathi District.

The objectives of the audit, in accordance with the ISO standards for auditing are to;

- Verify compliance and non-compliance with the Waste Management Licence and the OEMP.
- Make appropriate audit findings, based on verified evidence.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

#### **4. POINTS AWARDED FOR SPECIFIC GOALS**

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

### CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
